#### THE DIFFERENCE

BETWEEN "CHAPTER BENEFITS" AND "MEMBER BENEFITS" OR "WHY DO I HAVE TO JOIN THE FAEP WHEN I JOIN A LOCAL CHAPTER?

The FAEP is comprised of the state chapter and eight local chapters. Having local chapters enables the association to provide training, educational opportunities and networking throughout the state in a very cost effective and convenient manner. Local chapters also provide the opportunity to address local matters that are of interest to you.

The FAEP functions as an administrative arm to serve your local chapter. The administrative tasks FAEP handles are behind the scenes and most FAEP members are likely unaware of how much the FAEP does for the local chapters which in turn benefit the local chapter members. The FAEP assumes responsibility for the local chapters for the following matters:

- Provides financial support to the local chapter hosting the annual FAEP conference;
- Provides financial support to the local chapters to help with local events such as member appreciation events and training. This additional financial support enables many chapters to offer low or no cost events to its members;
- Provides general liability insurance for the local chapters (often required by venues where we hold our events);
- Files the annual IRS tax filings;
- Files and pays for the annual state registration with the Department of State, Division of Corporations;
- Files and pays for the annual state registration with the Department of Agriculture and Consumer Affairs;
- Pays for the NAEP/FAEP Affiliated Chapter annual fee;
- Operates and maintains the FAEP webpage:
- Maintains the membership database including tracking membership renewal dates and sending renewal notices:
- Sends the monthly calendar of events to the FAEP membership;
- Publishes the FAEP quarterly newsletter The Beacon.

We found it was efficient and organized to have the FAEP handle these administrative matters.

## President's Message Continued...

By providing these services, the burden has been taken off the local chapters and has centralized the administrative aspects of the organization into one location. These things are "chapter benefits." It benefits the chapters and chapter leadership. The local chapters and chapter leadership are then able to devote more time and more resources to providing member benefits such as training sessions, monthly luncheons, networking events and more.

Membership in the FAEP also provides members benefits from the National Association of Environmental Professionals through the NAEP/FAEP Affiliation Agreement, including discount rates to participate in the NAEP webinars and discount registration for the NAEP annual conference. This will be particularly valuable when the FAEP hosts the 2014 NAEP annual conference April 7-10 in St. Petersburg. We will be working for even more benefits from the NAEP in the coming months.

Admittedly these activities are not glamorous. Frankly, the administrative matters are tedious and time consuming. However, in many instances (IRS, Sunbiz, FDACs) they are legally required and in others (insurance, membership database and webpage, monthly event calendar), they just make good sense.

With this additional responsibility comes additional cost. The FAEP is limited in the ability to generate revenue. While there are a number of FAEP sponsorship opportunities, the primary source of income for the FAEP is membership dues. For this reason, the FAEP Board of Directors recently made a tough but necessary decision to adjust the membership dues rate beginning in the FAEP 2013-2014 fiscal year.

Effective October 1<sup>st</sup>, the FAEP membership rate will change from \$30 to \$40. This is the first rate change in eight years. Even with this change, the FAEP still has one of the nation's lowest price membership rates for a professional organization. Given the generous member discounts offered at the local chapter events (often free to members) and the FAEP and NAEP annual conferences, it is likely your FAEP membership will pay for itself in only one or two FAEP events.

Members can renew any time **before October 1**<sup>st</sup> at the \$30 rate, regardless of your current renewal date. Even if your renewal date is September 30, 2014 you can add another year to your membership at the current \$30 rate. If you renewed last month, same thing – go ahead and renew now to extend your membership at the previous rate (\$30) for another year.

## Mark your calendars for two FAEP events that highlight the skills and diversity of environmental professionals in Florida and Nationally.

First up is the 2013 FAEP Annual conference, hosted by the Central Florida Chapter of the FAEP. The Conference is scheduled for September 11-13 at the Double Tree Hotel at Universal Orlando. Room rates are a very reasonable \$97/ night. You can make your reservation from the FAEP website at www.FAEP-FL.org. The CFAEP will be hosting a Certified Environmental Professional workshop and networking social on Wednesday, Sept. 11<sup>th</sup>. Thursday will be a full day of speakers on a variety of topics. The conference will come to a close on Friday with a half day of speakers and optional golf outing. The registration fee is \$150 for FAEP members and \$200 for non-members. If you are not already a member of FAEP, consider joining now to take advantage of the discounted membership rate for the 2013 FAEP and 2014 NAEP conferences! Next is the **2014 National Association of Environmental Professionals, April 7-10, 2014 in St. Petersburg** hosted by the Tampa Bay Chapter and FAEP. The call for papers is open now. 
#### In conclusion

# NAEP August 7, 2013 webinar announcement ACHP/CEQ Guidance for Integrating NEPA and Section 106

The Federal environmental review processes under Section 106 of the National Historic Preservation Act (NHPA) and the National Environmental Policy Act (NEPA) encourage coordination and integration of the two processes. To support efficient planning, the Advisory Council on Historic Preservation (ACHP) and Council on Environmental Quality (CEQ) developed new guidance entitled "NEPA and NHPA: A Handbook for Integrating NEPA and Section 106." This new handbook explains the relationship between Section 106 and NEPA, strategies on how to coordinate the processes, and the Section 106 substitution process. Substitution authorizes agencies to use the procedures and documentation required for an Environmental Assessment or Environmental Impact Statement (EIS) to comply with Section 106 in lieu of the procedures in Title 36CFR 800.3 through 800.6. The National Park Service (NPS) is a leader in use of the substitution process.

## Florida's Air Emissions Hit All-Time Low in 2012

#### DEP's continued regulation, improvements by major sources leads to cleaner Florida air

In 2012, air emissions from Florida's industrial facilities hit their lowest levels since the FDEP began tracking them in 1985, due to the Department's oversight and facilities' use of new technology to curb pollutants.

Since 2010, annual air emissions have declined nearly 22% to 412,628 tons. A decade ago, Florida's industrial facilities emitted nearly 1.1 million tons of pollutants annually. The result is that Florida's air quality has improved and Florida can boast that its air quality is among the best in the nation.

Earlier this year, the <u>American Lung Association</u> released its 2013 State of the Air study, which reported that Florida experienced zero unhealthy days for ozone pollution during the three-year study period. In addition, the Association ranked four Florida cities among the 16 cleanest nationwide for both year-round and short-term particle pollution.

"This is great news for Florida - fewer air emissions means a better air quality for Floridians and visitors," said Brian Accardo, Director of the Division of Air Resource Management. "Department staff is focused on ensuring regulated businesses comply with stringent emission limits and use the latest technology to curb pollution."

The Department also recognizes the benefit of incentivizing additional reductions. One successful initiative led by the Department in 2012 was the <u>Title Fee Holiday</u>, which reduced emissions by nearly 1,900 tons while saving Florida small businesses more than \$300,000 statewide. The Department's initiative allowed business that curbed emissions to have a \$5,000 fee waived. Title V is a federal program run by states in which facilities pay to offset the regulatory cost of controlling air emissions from certain industrial facilities. Ultimately, 281 businesses kept their 2012 air emissions low enough to qualify for the fee holiday.

This year, if major industrial facilities emit fewer air emissions than authorized by permit, the Department will allow those facilities to pay fees only on the pollutants actually emitted. Previously, some facilities would pay fees only on allowed emissions. The Department's new approach will provide businesses a financial incentive to reduce pollution. Continued use of traditional regulatory and incentive-based measures such as these will assure that Florida is as prepared as possible to comply with increasingly stringent national clean air standards.

The Department's website allows the public to monitor updated air quality information through its <a href="Spatial Air Quality">Spatial Air Quality</a> System. Web users are able to access updated air quality data as reported by Florida's statewide network of air quality monitors. Additional information about Florida's air quality is available through the Department's Division of Air Resource Management website.
